Description of the project

A description of the proposed broadband project plan.

This project provides "middle mile" investment, and requires the placement of 6 miles of fiber from the Seneca central office to the Ferryville service device, and provides updated electronics at the serving device. The project will provide up to 40 Mbps at the service device. There are approximately 234 living units in the area of Ferryville. This application is in the area of the Seneca exchange.

The broadband service speed to the customer depends on how close they are located to the serving device. As shown in the chart below, the shorter the distance to the customer the higher the available broadband speed.

The chart below shows the relationship between data speeds available and distance from the serving device:

Itemized statement of funding request

Proposed budget.

The total construction costs are \$250,000 for constructing 6 miles of fiber and updating the electronics at the serving device. CenturyLink is seeking a broadband expansion grant of \$200,000. CenturyLink has included only costs directly associated with the project construction. The grant will not subsidize operating costs or profits. Absent receiving the broadband expansion grant CenturyLink will not undertake the project. Please see Attachment C for the details of the proposed budget. **This attachment is confidential**.

Priority factor's supporting the application

The applicant's financial match.

The proposed budget for this project was provided above. The total estimated cost of this project is \$250,000. CenturyLink will fund 20% of this project, or \$50,000.

Broadband Providers.

CenturyLink provides internet service in the Seneca – Ferryville area but the maximum speed we can offer using existing facilities is 1.5 Mbps. CenturyLink is at capacity for the area so we are unable to provide any internet service to new customers. According to the information from the National Telecommunications and Information Administration's end-of-year 2012 data, there is one broadband provider (Mediacom) in the Ferryville project's area. The Ferryville project is a middle mile project so we can't exclude the census blocks shown to be served by Mediacom and still serve the other census blocks that are underserved. Further, given that the local communities' support for this Ferryville project is primarily due to the lack of broadband service being available in the area, it raises questions whether Mediacom is actually providing broadband speeds at 3 Mbps or higher in the project area.

Description of public-private partnership / Letter of Support.

While CenturyLink has not yet entered into a formal public-private partnership, CenturyLink has received letters of support for this project from the Village of Ferryville and the Crawford County Economic Development Corporation, which express their strong support for this project because it will aid area businesses, home businesses, and residential customers. The letters are included as Attachment D. CenturyLink continues to work with interested groups in the area to gather additional support for the project, which may result in public-private partnerships or they may submit additional letters of support.

Description of the area.

The Ferryville project is located in Crawford County in southwestern Wisconsin. The area is rural and located along Highway 35 and the Mississippi River and inland. The population in the Ferryville project is 250. The area is a mix of residential and business. As noted by the Crawford County Economic Development Corporation "The total economic impact of expanding

An estimate of the number of potential new broadband subscribers.

This project will provide broadband service to approximately 234 living units that currently have access to broadband at speeds of no more than 1.5 Mbps download.

The applicant's financial and network qualifications.


CenturyLink files an Annual Questionnaire with the Wisconsin Commission.

Customer Benefit of the Broadband Expansion Grant Program.

It is uneconomic for CenturyLink based on the cost of the project and number of customers in the area to provide broadband service above 1.5 Mbps to these customers in the proposed project area, absent additional support. Further, CenturyLink is at capacity in the Ferryville area and cannot offer even 1.5 Mbps internet service to new customers. Unless the Commission approves CenturyLink's application, it is highly likely citizens in the proposed project area will not be able to receive broadband speeds exceeding 1.5 Mbps. If the project is approved, both businesses and residential customers will be able to obtain higher broadband speeds that will improve not only their own bottom lines, but improve the economy for all citizens in the area.

RE: Proposed CenturyLink broadband infrastructure expansion from State Trunk Highway 171 to Village Ferryville and vicinity.

Mr. Klaila:

Crawford County Economic Development Corporation (CCEDC) staff strongly supports the application by CenturyLink to provide broadband service to the Village of Ferryville through a new fiber optic cable project. CenturyLink's service extension would serve residences and small businesses alike, and it is important to note that numerous home occupation businesses have the potential to benefit as well.

Expanding broadband choice for small business has real impact. Greater use of broadband makes small businesses more productive. For service oriented firms, such an increase in productivity has been estimated to be as high as ten percent. Access to broadband technology also lowers transaction costs and allows entry into new markets, making smaller companies more competitive. In addition, small business owners increasingly view broadband as a necessary condition to start operations in a given location. ⁱ

The Ferryville Village Board has been involved with employees of Centurylink requesting more reliable and faster internet service be provided to the greater Ferryville area in Crawford County. Seventy five percent of our residents and commercial locations in the community, unfortunately have no options for an internet provider other than the services offered by Centurylink. The current service is woefully inadequate for the needs of several home businesses as well as our local branch bank and mail order cheese store. Our Village participates aggressively with the Crawford County Economic Development Corporation and we have had contacts by companies to locate here but all require faster internet connection than is offered to our community. The future of this community requires an increased tax base and more employment opportunities.

The representatives of Centurylink have informed our Board that company funds are not available to upgrade their equipment, nor install lines to improve this underserved part of the State at the current time. However, we have recently been informed that our provider is seeking grant funds provided by the Broadband Expansion Grant Program created by the current State budget.

The Village Board supports this effort one hundred percent and urges that you give funding support to Centurylink. The greater Ferryville area is in a struggling economic area and we need fast and reliable internet service in order to have any chance to attract any new business opportunities. Please consider the request of Centurylink to provide them reimbursement of their expenses to improve the broadband telecommunications service to our underserved area of Wisconsin.
