Concerned Citizens is uniquely qualified to speak to said characteristics / attributes because it is made up of individuals and families that own land, live, and work in the area. Concerned Citizens will not be directly impacted however if one of the other routes under consideration is chosen or if the "no build option" is decided on, therefore the impact on Concerned Citizens is directly related to the decision and order of the Commission. We regard these experts as absolutely vital to the task of addressing and conveying the extremely subtle nuances of Amish life along the proposed 345 KV transmission line (segment O).

In essence, they live in a world that is quite foreign from the modern ways of life that surround them. Many have expressed that we speak different languages. This is accurate both figuratively and literally as English is the second language for most Old Order Amish.

Concerned Citizens of Highway 33 has no funding sources to compensate the expert support needed to convey a way of life that may very well be threatened by the construction of a transmission line.

We are anticipating his spending time conducting research within the Amish community that will be directly impacted by the proposed construction of the 345 KV transmission line. It is our hope that he will facilitate the expression of this community's convictions and concerns regarding the line. The costs of his services will include time for research and report development and trips from Decorah, Iowa to conduct research in the field (time and expenses). He will also need to summarize his findings in the form of a report and be available for testimony and cross-examination. Further information about Professor Zook is provided in his attached CV.

He will spend time conducting field research with community members and his report will serve to convey the issues surrounding the proposed routing in a culturally sensitive manner. The costs of his services will include trips from Madison, WI to the site as well as time for research and report development (time and expenses).
