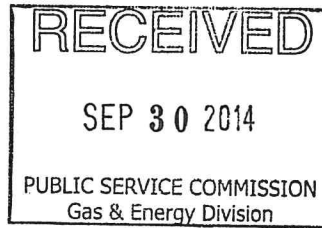

## RESOLUTION OF THE TOWN BOARD TOWN OF MADISON, DANE COUNTY, WISCONSIN

The Town Board of the Town of Madison, Dane County, Wisconsin, meeting this 15th day of September 2014, does hereby resolve as follows:

**WHEREAS**, Madison Gas & Electric (MGE) has filed for restructured electric rates with the Wisconsin Public Service Commission (Docket No. 3270-UR-120);

**WHEREAS**, MGE's proposed restructured electric rates will increase total costs for low-use customers such as apartment residents by increasing fixed monthly customer charges, encouraging electric use, and discouraging energy efficiency;

**WHEREAS**, the Town of Madison has a population of 6,300 persons of which 70% or about 4,400 persons are apartment residents;

**WHEREAS**, the Town of Madison has a high percentage of low-to-moderate-income residents and residents on fixed incomes living in apartments that will be adversely affected by significantly higher electric bills;




