RE: Request to Approve a Mutual Traffic Exchange Agreement Between TDS TELECOM and Charter Fiberlink, LLC. Pursuant to 47 U.S.C. Section 252(e)

TDS TELECOM hereby requests approval pursuant to 47 U.S.C. s. 252, of the voluntary mutual traffic exchange agreement with Charter Fiberlink, LLC, dated December 16, 2004. The agreement allows the parties to exchange all local traffic, Extended Area Service traffic, and Extended Community Calling traffic with each other by direct interconnection of their respective networks or by transiting such traffic through third party LEC tandems.
