TDS Telecommunications Corporation (TDS Telecom) hereby requests approval pursuant to 47 U.S.C. s. 252, of the fourth amendment to the voluntary wireless interconnection agreement between the following TDS Telecom operating companies and US Cellular Corporation.

- Burlington, Brighton & Wheatland Telephone Company, LLC

The original interconnection agreement became effective April 15, 2004 and was approved by the Commission in Docket 05-TI-1125 on November 22, 2004. The fourth amendment adds BB&W to direct interconnection arrangements and establishes direct interconnection points for BB&W's exchanges and the Wind Lake exchange of Southeast Telephone Company of Wisconsin, LLC.

Fourth Amendment to Wireless Traffic Exchange Agreement

The Wireless Interconnection Agreement, effective the 15th day of April 2004, between the TDS Telecommunications Corporation affiliates or subsidiaries identified on Appendix A of the named Agreement ("TDS TELECOM"), and United States Cellular Corporation, a Delaware corporation ("USCC"), approved by the Public Service Commission of Wisconsin in 05-TI-1125 on November 22, 2004 is hereby amended as follows:

To the Appendix A – Reciprocal Compensation Rates and Billing Procedures, the following Companies and \$/MOU to be added under Type 2B Direct Interconnection:

<u>Company</u>	<u>\$/MOU</u>
Burlington, Brighton & Wheatland Telephone Company, LLC	\$0.0079

To the Appendix B – Direct Interconnection Points, the following meet points shall be added under Type 2B Interconnection Service:

7. The meet point for local traffic to and/or from United States Cellular Corporation and the Wheatland and Bohner's Lake exchanges subtending Burlington, Brighton & Wheatland Telephone Company's Bohner's Lake host switch shall be at the Bohner's Lake central office CLLI (BHLKWIXADS1).
8. The meet point for local traffic to and/or from United States Cellular Corporation and the Wind Lake exchange of Southeast Telephone Company shall be at the Wind Lake central office CLLI (WDLKWIXADS1).

The remaining terms and conditions of the Agreement shall remain in effect. This Amendment shall be effective as of March 1, 2008.
