The first Amendment adds direct interconnection points for Stockbridge & Sherwood Telephone Company, LLC to the Agreement.

The amendment to the interconnection agreement became effective March 1, 2008. The original agreement was approved in Docket 05-TI-1733.

First Amendment to Wireless Traffic Exchange Agreement

The Wireless Interconnection Agreement, effective the 20th day of August 2007, between the TDS Telecommunications Corporation affiliates or subsidiaries identified on Appendix A of the named Agreement ("TDS TELECOM"), and Dakota Wireless Group, LLC, a Wisconsin corporation d/b/a Bug Tussel ("Bug Tussel"), approved by the Public Service Commission of Wisconsin in 05-TI-1733 on November 28, 2007 is hereby amended as follows:

To the Appendix B – Direct Interconnection Points, the following meet points shall be added under Type 2B Interconnection Service:

1. **The meet point for local traffic to and/or from Dakota Wireless Group, LLC and the Tisch Mills exchange of Stockbridge and Sherwood Telephone Company shall be at the Tisch Mills central office CLLI (TSMLWIXADS0).**
2. **The meet point for local traffic to and/or from Dakota Wireless Group, LLC and the Sherwood and Stockbridge exchanges subtending Stockbridge and Sherwood Telephone Company's Sherwood host switch shall be at the Sherwood central office CLLI (SHWDWIXADS0).**

The remaining terms and conditions of the Agreement shall remain in effect. This Amendment shall be effective as of March 1, 2008.
