The Traffic Exchange Agreement referenced above was approved by the Public Service Commission of Wisconsin on January 31, 2006. The initial expiration date of the agreement was December 20, 2008.

Pursuant to Section 2.1 of the Agreement, CenturyTel offered to extend the term of the Agreement for an additional three (3) years, resulting in a new termination date of December 20, 2011.



On December 20, 2005, Comcast Phone of Wisconsin, LLC ("Comcast") entered into a Traffic Exchange Agreement ("Agreement") with CenturyTel of Central Wisconsin, LLC, CenturyTel of Fairwater-Brandon-Alto, LLC, CenturyTel of Forestville, LLC, CenturyTel of Larsen-Readfield, LLC, CenturyTel of Monroe County, LLC, CenturyTel of Northern Wisconsin, LLC, CenturyTel of Northwest Wisconsin, LLC, CenturyTel of Southern Wisconsin, LLC, CenturyTel of the Midwest-Kendall, LLC, CenturyTel of the Midwest-Wisconsin, LLC, CenturyTel of Wisconsin, LLC, Telephone USA of Wisconsin, LLC (collectively, "CenturyTel") approved by the Wisconsin Public Service Commission in Docket 05-TI-1478 . According to the Agreement, the Term will expire on December 20, 2008. Pursuant to Section 2.1 of the Agreement, CenturyTel herein offers to extend the Agreement an additional three (3) years. This would result in a new Termination Date of December 20, 2011.

The authorized representatives of CenturyTel and Comcast hereby agree, pursuant to Sections 2.1 and 3 of the Agreement, to extend the existing Agreement as defined herein and establish a new Termination Date of December 20, 2011. Except as modified herein or by subsequent voluntary or change of law amendment, all other terms of the Agreement shall remain unchanged and in full force and effect.


