The Adoption of the Interconnection Agreement referenced above is a new agreement between the above mentioned parties. The expiration date of the enclosed Adoption of the Interconnection Amendment is May 8, 2016. If neither Party elects to terminate this Agreement as of that date, this Agreement shall continue on a month-to-month basis unless and until cancelled or terminated as provided for in the Agreement.

Big River Telephone Company, LLC is adopting the Interconnection Agreement and ICC VoIP Amendment between CenturyLink entities and Tri-County Telcom, Inc. which were approved by the Commission in Docket No. 5-TI-2367, as well as the Point of Interconnection Amendment between CenturyLink entities and Tri-County Telcom, Inc. which was approved by the Commission in Docket No. 5-TI-2396. All three of the agreements being adopted are provided for reference.

CenturyLink hereby files for approval of the above referenced Adoption of the Interconnection Agreement pursuant to 47 USC § 252 of the Telecommunications Act.
