The 2nd Amendment adds Utelco, LLC and The State Long Distance Telephone Company, LLC to Appendix A of the ICA. This 2nd amendment has been corrected and re-signed to reflect CenturyLink Communications as the legal signatory, removing CT Acquisition and CenturyTel Fiber II which were voluntarily de-certified and merged into CenturyLink Communications LLC April 1, 2014.


To Appendix A, the following TDS affiliate companies are be added:


