INTERCONNECTION AGREEMENT AND SETTLEMENT AMENDMENT FOR

SPRINT COMMUNICATIONS COMPANY L.P. INDIANA, WISCONSIN

Sprint Communications Company L.P. has signed a Negotiated Interconnection Agreement along with an Amendment for the states of Indiana and Wisconsin. Some of the Appendices were ported while others were from the Sprint Communication Company L.P. Illinois Agreement. Included for the GTC there are 4 signature pages and also there are 4 signature pages for the UNE amendment.

The agreement includes freely negotiated language in the following appendices: 800, 911, Directory Assistance, LIDB CNAM, Merger Conditions, Reciprocal Compensation, Resale, Operator Services and Structure Access.
