On October 31, 2003, McLeodUSA Telecommunications Services, Inc. d/b/a PAETEC Business Services entered into a Traffic Exchange Agreement ("Agreement") with CenturyTel of the Midwest-Kendall, LLC ("CenturyTel") approved by the Wisconsin Public Service Commission in Docket 05-TI-896. Due to the acquisition of McLeodUSA Telecommunications Services, Inc. by PAETEC Business Services on February 8, 2008, this letter reflects the name of the new operating entity also known as McLeodUSA Telecommunications Services, Inc. d/b/a PAETEC Business Services. According to the Agreement, the Term expired on October 31, 2005. CenturyTel herein offers to extend the Agreement an additional two (2) years which would result in a new Termination Date of October 31, 2011.


