The Wireless Interconnection Agreement, effective the 1st day of December, 2000, between the Wisconsin telephone company subsidiaries of TDS TELECOMMUNICATIONS CORPORATION ("TDS"), and New Cell, Inc., a Wisconsin corporation ("CELLCOM"), approved by the Public Service Commission of Wisconsin in 05-TI-436 on March 21, 2001 is hereby amended as follows:
