The Amendment referenced above is an amendment to the Local Traffic Exchange Agreement between the above mentioned parties dated June 7, 2005. The Agreement had an initial term on one year, but if neither Party elects to terminate this Agreement as of that date, this Agreement shall continue unless either Party gives 60 days notice of termination as provided for in the Agreement.

**AMENDMENT NO. ONE TO
LOCAL TRAFFIC EXCHANGE AGREEMENT**

This Amendment No. ONE ("Amendment"), effective October 10, 2010, is entered into by and between the City of Reedsburg, Wisconsin acting through the Reedsburg Utility Commission ("RUC") and CenturyTel of Central Wisconsin, LLC d/b/a CenturyLink, CenturyTel of the Midwest-Wisconsin, LLC d/b/a CenturyLink, CenturyTel of the Midwest-Kendall, LLC d/b/a CenturyLink (collectively "CenturyLink"), (CenturyLink and RUC may be referred to individually as a "Party" and collectively as the "Parties").

RECITALS

WHEREAS, RUC and CenturyLink entered into a Local Traffic Exchange Agreement dated June 7, 2005 (the "Agreement"); and

WHEREAS, RUC desires to start providing Local Service in three new Verizon/Frontier areas in Wisconsin that have local calling to CenturyLink; and

WHEREAS, RUC and CenturyLink desire to modify the Agreement to incorporate the new local calling areas; and

NOW THEREFORE, in consideration of the promises and agreements contained in this Amendment, the Parties agree as follows:

AMENDMENT

1. In Section 2, replace Brad Niebuhr as the copy to notice contact with the following copy to notice contact for RUC:

2. Delete Section 5 of the Agreement and replace with the following Section 5:

The Parties agree to limit this adoption letter to the exchange of ECC traffic between; a) CenturyLink's Baraboo, Wonewoc, and North Freedom rate centers with the Reedsburg Utility Commission's Reedsburg rate center, b) CenturyLink's North Freedom and Wonewoc rate centers and the Reedsburg Utility Commission's Lime Ridge rate center, and c) CenturyLink's Baraboo and North Freedom rate centers and the Reedsburg Utility Commission's Loganville and Wisconsin Dells rate centers.

3. Delete Section 6 of the Agreement and replace with the following Section 6:

The Parties will continue to exchange ECC traffic using the current interconnection arrangements; a) 1 DS-1 between the CenturyLink Baraboo switch (BARBW101DSA) and the Reedsburg Utility Commission switch (RDBGWIBVDS1), and b) 1 DS-1 between the CenturyLink Tomah switch (TOMAWIXADSA) and the Reedsburg Utility Commission switch (RDBGWIBVDS1). The Reedsburg Utility Commission will continue to provide Interconnection points at the applicable switch or at a meet point within the applicable switch exchange boundary.

4. Except as modified herein, the terms and conditions of the Agreement shall continue in full force and effect. In the event of a conflict between the terms of the Agreement and this Amendment, this Amendment will control.


