The Wireless Interconnection Agreement, executed and effective on the 16th day of October, 1997 between the Wisconsin telephone subsidiaries of TDS TELECOMMUNICATIONS CORPORATION, a Delaware Corporation ("TDS"), and AIRADIGM COMMUNICATIONS, INC., a Wisconsin Corporation ("Airadigm"), approved by the Public Service Commission of Wisconsin in 05-TI-164 on December 8, 1997 is hereby amended as follows:
