Dear Ms. Paske:

The Traffic Exchange Agreement referenced above is a new agreement between the above mentioned parties. The expiration date of the enclosed Traffic Exchange Agreement is July 8, 2016. If neither Party elects to terminate this Agreement as of that date, this Agreement shall continue on a month-to-month basis unless and until cancelled or terminated as provided for in the Agreement.

The expiration date of the ICC VoIP Amendment to the Interconnection Agreement is the same as the expiration date of the Traffic Exchange Agreement, July 8, 2016. If neither Party elects to terminate this Agreement as of that date, this Agreement shall continue on a month-to-month basis unless and until cancelled or terminated as provided for in the Agreement.

CenturyLink hereby files for approval of the above referenced Traffic Exchange Agreement and the ICC VoIP Amendment to the Interconnection Agreement pursuant to 47 USC § 252 of the Telecommunications Act.


