The parties entered into the Interconnection and Reciprocal Compensation Agreement referenced above in 2010, but due to an administrative oversight, the agreement was not previously submitted to the commission for approval. As a result, both the underlying Interconnection and Reciprocal Compensation Agreement and recently-executed Amendment No. 1 thereto are being submitted to the Commission simultaneously for approval.
