The expiration date of the enclosed agreement is the same as the interconnection agreement, September 25, 2015. If neither Party elects to terminate this Agreement as of that date, this Agreement shall continue on a month-to-month basis unless and until cancelled or terminated as provided for in the Agreement.

CenturyLink hereby files for approval of the above referenced Point of Interconnection Amendment to the Interconnection Agreement pursuant to 47 USC § 252 of the Telecommunications Act.


