The Adoption of the Traffic Exchange Agreement and ICC VoIP Amendment referenced above is a new agreement between the above mentioned parties. The expiration date of the enclosed Adoption of the Traffic Exchange Agreement and ICC VoIP Amendment is September 25, 2015. If neither Party elects to terminate this Agreement as of that date, this Agreement shall continue on a month-to-month basis unless and until cancelled or terminated as provided for in the Agreement.

Baldwin Broadband, LLC is adopting the Traffic Exchange Agreement between CenturyLink entities and Comcast Phone of Wisconsin, LLC which was approved by the Commission in Docket No. 5-TI-2282, as well as the ICC VoIP Amendment between CenturyLink entities and Comcast Phone of Wisconsin, LLC which was approved by the Commission in Docket No. 5-TI-2317. Both of the agreements being adopted are provided for reference.


