The purposes of an analytical review are to detect possible reporting or accounting related errors and to identify significant fluctuations from established trends in reported data not sufficiently explained in the annual report. It is our hope that our review will supply information that will enable us to better provide guidance to your utility regarding proper utility accounting and the preparation of future annual reports. In order to complete this review, we request the following information:

1. In the future, when providing composite depreciation rate, page F-7, line 22, please report as a decimal. For example, the water depreciation rate reported as 2.26 percent should be reported as .0226 .
2. In the future, when completing the Notes Payable and Miscellaneous Long-Term Debt schedule, page F-14, please provide detail in column (a). Also, please report the year as a four-digit number in columns (c) and (d).
3. During our review, we noted dollars reported in the balance sheet for accounts 124 and 142. However, the supporting schedules, page F-18, were not completed. Please complete these schedules in all future annual reports
4. During our review of the Pumping and Power Equipment schedule, page W-12, we noted that location, line 2, purpose, line 3, and destination, line 4, were not provided for Unit A or Unit B. Please provide this information, and continue this procedure in the future.
5. During our review of the Reservoirs, Standpipes, and Water Treatment schedule, page W-13, we noted that type, column (a), was not provided. Please provide this information in all future reports.
6. During our review of the Mains schedule, page W-14, we noted that Main Function, column (b), was not provided. Please provide this information in all future reports.
7. During our review of the Meters schedule, page W-16, we noted that end of year, column (f), and totals, column (o), of the classification of meters schedule, do not agree. Please reconcile these differences.
8. During our review of the Sewer Taxes schedule, page S-6, we noted that remainder assessment was not reported. We assume this was reported as a miscellaneous; however, in the future please report in the Taxes schedule.
9. During our review of page IV, we noted several lines that were not completed. Please provide the following: when utility was organized, office address of person in charge of correspondence concerning this report, and names of members of utility commission.
