3. During our review of page W-10, we noted you reported a 30 percent water loss in 1997 and 25 percent in 1996. We also noted your comment of amounts given for utility use. Please explain what this use was and what is being done about the water loss.

We appreciate your cooperation in providing the above information. These recommendations are intended to provide accounting assistance and should not be construed as criticisms of utility personnel.
