2. During our review we noted that while you report additions during the year for account 348, hydrants, in column c of line 31 of the Water Utility Plant In Service schedule on page W-8, you do not report any hydrants as added during the year in column c of the Hydrants And Distribution System Valves schedule on page W-17. Please explain.
3. As directed in head note number 5 at the top of page W-14, please explain how the mains reported as added during the year in column e of the Water Mains schedule were financed.
4. As directed in head note number 3 at the top of page W-15, please explain how the services reported as added during the year in column d of the Water Services schedule were financed.
5. Please provide the breakdown by size for the 52 meters reported as tested during the year in column g of the Meters schedule on page W-16.
6. The Commission is now using a computerized system to build an annual report data base. It is, therefore, important to have a complete and
