The Public Service Commission has completed their analytical review of your 1998 annual report. The primary purpose of our analytical review is to detect possible accounting related errors and to identify significant fluctuations from prior year's data, which are not sufficiently explained in the footnotes of your annual report.

1. During 1996 the Commission adopted benchmark depreciation ranges for water utilities, which has resulted in increased depreciation expense for many utilities because of more stringent rules on water quality, a shorter recovery period for mains, and changes in meter technology. The staff has reviewed the adequacy of depreciation rates for your utility and has determined that a revised composite depreciation rate of 2.11 percent should be used, effective January 1, 1999. The computation of the revised 2.11 percent rate is provided on the enclosed schedule.

2. In the future, as directed in the headnotes of both the Water Operation & Maintenance Expenses schedule on page W-5 and the Sewer Operation & Maintenance Expenses schedule on page S-5, please provide explanations of all significant expense fluctuations when compared to the previous year.

3. Our records indicate that the dollars reported in Account 311 of the Water Utility Plant in Service schedule on page W-8 should actually be in Account 310 and the dollars reported in Account 390 should actually be in Account 379. Please make these adjustments to your 1999 annual report using column (f) and add a footnote explaining that those adjustments were made as directed by this letter.
