Dear Mrs. Meyers:

Thank you for your response to our 1999 analytical review letter. Item 2 indicates that social security tax is recorded along with payroll charges to the proper labor accounts.

In the future, social security, unemployment benefit, and other forms of payroll taxes, to the extent applicable to operating payrolls, should be included in Account 408, Taxes. Payroll taxes should not be distributed over the various accounts to which the payroll was charged. Portions of payroll taxes that are applicable to construction should be distributed directly or through clearing accounts to the appropriate plant accounts. Likewise, any such payroll taxes applicable to non-utility operations should be charged to the appropriate non-utility expense account.

If the payroll tax is paid by the municipality, the utility's share of this expense should be charged to the accounts as discussed above with the offsetting credit being made to Account 233, Payable to Municipality. If the Municipality will not require reimbursement for this expense, then the liability may be written off to Account 216, Unappropriated Earned Surplus.

Thanks again for your cooperation with this review. Your 1999 analytical review is closed.
