The Public Service Commission has completed their analytical review of your 1999 annual report. The primary purpose of our analytical review is to detect possible accounting related errors and to identify significant fluctuations from prior year's data, which are not sufficiently explained in the footnotes of your annual report. We have no questions, only the following comments.

1. We noted amounts reported in Account 682, Outside Services Employed, Water Operation & Maintenance Expenses schedule, described as well testing and water tank maintenance. Account 682 is usually professional fees such as engineering, consultants, and accountants. In the future, water tank maintenance is more appropriately reported in Account 650, Repairs of Water Plant, and well testing is more appropriately reported in Account 640, Supplies and Expenses.

2. We noted you are reporting \$879 as the current tax equivalent on the Property Tax Equivalent schedule, and then reporting it as forgiven in Account 434, Miscellaneous Credits to Surplus. In the future, please report 0 in the cell "any lower tax equivalent as authorized" on the Property Tax Equivalent schedule and footnote that schedule that the municipality has authorized zero. Then there will not be a tax equivalent amount brought forward to Account 408, Taxes, to forgive. It is noted in your rate case file that the municipality has set your rate at zero. That is different from a situation where the rate is not set at zero and the municipality forgives the tax equivalent.

3. We noted water was reported on page W-10 as "purchased." Please revise your schedule to report gallons as "ground water" column (d), and follow this procedure in the future. Your utility pumps its water from a well.
