The Public Service Commission (Commission) is in the process of completing an analytical review of your utility's 1999 annual report. The purposes of an analytical review are to detect possible reporting or accounting related errors and to identify significant fluctuations from established trends in reported data not sufficiently explained in the annual report. It is our hope that our review will supply information that will enable us to better provide guidance to your utility regarding proper utility accounting and the preparation of future annual reports. In order to complete this review, we request the following information:

1. The Commission is establishing a database and guidelines for the average cost of meters. Based upon a review of your utility's data, the average cost of meters was \$170. Please provide copies of invoices for the meters installed in 1999. In addition, please provide the average cost to install the meters. Thank you for your cooperation with our meter project.
2. As directed in item number 2 of the head notes for the Other Operating Revenues schedule on page W-4, please provide detail regarding the \$2,277 reported in Account 474, Other Water Revenues.
3. The \$96,306 cost of 3,776 feet of water mains added on page W-15, column (e), was erroneously charged to Account 316, Supply Mains, rather than to Account 343, Transmission and Distribution Mains, as reported on page W-8, column (c), lines 10 and 27. Please confirm that the \$96,306 will be reclassified from Account 316 to Account 343 in 2000.
4. During our review, we noted there were no social security taxes reported in the Taxes schedule on page W-6. Please review the enclosed copy of page 12 from Section 4 of the Water Utility Reference Manual which explains how to account for social security taxes and follow this procedure in the future.

We appreciate your cooperation in providing the above information. These recommendations are intended to provide accounting assistance and should not be construed as criticisms of utility personnel.
