3. During our review, we noted that according to our calculations, the amount the utility reports for public fire protection service billed per Rate Schedule F-1 in Account 463 on the Other Revenues (Water) schedule, page W-4, differs from our calculation by \$615 (see enclosed worksheet). Please provide an explanation of how the utility arrived at the number reported on line 1 of Account 463, Public Fire Protection Service on page W-4.
4. Please explain why there are no social security taxes reported in the Taxes schedule on page W-6.
5. As of today's date our office has not received a response to our letter of June 9, 2000 (copy enclosed) regarding our review of the utility's 1999 annual report. Please provide your response to that letter at this time.
