2. As directed in the head notes of the Water Operation & Maintenance Expenses schedule on page W-5, please explain the difference between the \$5,332 reported in Account 682 in 1999 and the \$2,916 reported in 2000.

We appreciate your cooperation in providing the above information. These recommendations are intended to provide accounting assistance and should not be construed as criticisms of utility personnel.
