In future reports:

- The \$6,081 in Account 183, Other Deferred Debits on page F-18 described as BAL OF FUNDS LOANED TO 3 MUNICIPALITIES SEWER PROJECT should be reported in Account 124, Other Investments. Also, please provide a schedule note to Account 124 in 2001 with a description of the terms of the loan, when it is to be repaid as well as an explanation of the interest charges if there is interest being charged.
- The \$9,533 reported in Account 145, Receivables from Municipality on page F-18, described as prior year fire protection costs should be reclassified. Please note that in the future, Account 145 should only contain amounts that are subject to current settlement. Amounts that will be repaid, but over a longer period of time, should be reclassified to Account 123, Investment in Municipality or written off to Account 216, Unappropriated Earned Surplus.
