During our review we noted that according to our calculations, the amount the utility reports for public fire protection service billed per Rate Schedule F-1 in Account 463 on the Other Revenues (Water) schedule, page W-4, differs from our calculation by \$1,024 (see enclosed worksheet). Please adjust your 2001 Public Fire Protection Service charge to account for the undercharge in 2000 and use our worksheet as a guide in calculating the charge in the future.
