Dear Mr. Lankey:

The Public Service Commission staff is in the process of completing an analytical review of your utility's 2000 annual report. The purposes of an analytical review are to detect possible reporting or accounting related errors and to identify significant fluctuations from established trends in reported data not sufficiently explained in the annual report. It is our hope that this review will supply information that will enable us to better provide guidance to your utility regarding proper utility accounting and the preparation of future annual reports. In order to complete this review, we request the following information:

1. On page F-19, prior year amounts are reported in Account 233. Since Account 233 is for current amounts only, these amounts should be repaid, or reclassified to Account 223, Advances from Municipality, or written off to Account 216.
2. On page W-14, the water treatment portion of the schedule is not completed. However, on page W-8, \$18,464 is reported in Account 332, Water Treatment Equipment. Please furnish an explanation.
3. On page W-5, Account 930 decreased over 25 percent and \$5,000 from the prior year. Please furnish an explanation as requested in the schedule head note and follow this procedure in the future.
4. We appreciate your response to our January 4, 2001, letter about minimizing water loss. We understand that you intended to address the issue of bulk water and hydrant use in general. Has an agreement been reached with the Fire Department about reporting their use of water? As we indicated in our earlier letter, there are additional areas to focus on, namely meter accuracy (customer and supply meters), finding and repairing leaks throughout the distribution system as well as reducing unmetered use (meter if possible or estimate or measure in some other way). Since your unaccounted percentage is excessive, we will continue monitoring this and working with you as needed to help your utility improve in this area.

We appreciate your cooperation in providing the above information. These recommendations are intended to provide accounting assistance and should not be construed as criticisms of utility personnel.
