The Public Service Commission (Commission) staff has completed its analytical review of your utility's 2001 annual report. The primary purpose of the analytical review is to detect possible reporting or accounting related errors and also to identify significant fluctuations from prior years' data that are not sufficiently explained in the annual report. The analytical review did identify the following issues:

1. Please provide an explanation for the \$9,846 reported in Account 143, Other Accounts Receivable, page F-19. In the future, all amounts greater than \$5,000, even if grouped, should be explained.
2. Meters 6-inches and larger are to be tested annually when in use. It appears that there are four meters 6- and 8-inch classified as Public Authority that were not tested (page W-17). Please provide an explanation.
3. On page W-7, Utility Plant Jan. 1 does not agree with the gross plant reported on the Net Utility Plant schedule, page F-7 of the prior year annual report. See Headnote No. 4 on page W-7 for a description of Utility Plant Jan. 1. Please use the correct amount in the future.
4. On page F-2, the \$44,297 reported in Account 418 described as "CELLULAR PHONE TOWER RENTAL" is more appropriately reported in Account 472, Rents from Water Property, page W-4. Please follow this procedure in the future.
5. Please provide a more detailed description of the \$7,092 reported in Account 421 on page F-2 described as "SUNDRY". Please see Headnote No. 1 which indicates grouped amounts greater than \$5,000 should be explained.

Responding to the questions posed from the analytical review does not preclude you from possibly receiving other inquiries from our office regarding your annual report in the future: for instance, during a rate case, construction authorization, or other Commission reviews.
