Please note that this was a Listing of Edit Check Results item. In the future, all Listing of Edit Check Results items should be addressed before the annual report is filed.
2. On Page W-7, the amount reported for Utility Plant Jan. 1 does not agree with the amount reported for plant on Page F-7. The difference is immaterial, but please use the correct amount in the future.
3. On Page W-7, the other tax non-local was not explained. In prior years, this tax was explained as MMSD. Please furnish this explanation every year.

In addition, you may receive additional inquiries from our office regarding your annual report during a rate case, construction authorization, or other Commission reviews.

WATER OPERATING SECTION FOOTNOTES

Water Operating Revenues - Sales of Water (Page W-02)

Residential revenues increased during 2002 primarily as a result of installation of new meters which created more accurate readings of consumption and a reclassification of condominiums from the commercial category to residential.

Commercial revenues decreased as a result of the reclassification of the condominiums.

Industrial revenue decreased as a result of water conservation efforts and a business decline of the Utility's largest customer.

Water Operation & Maintenance Expenses (Page W-05)

Account 631 - prior year amounts included tuckpointing the building which is not a recurring cost, this year's expense is more in line with expected annual expense.

Account 651 - current year costs include tuckpointing, which results in greater than normal costs for the current year.

Account 676 - expenses have increased as a result of amortization of the loss on disposal of meters.

Water Utility Plant in Service (Page W-08)

Additions in Account 343 - Mains are for mains added by the City's TIF District as well as some costs to relocate a water main, which were financed with Utility funds on hand. Retirement of main represents the removal of main which was replaced by the City's project.

Additions in Account 345 - Services are for services added by the City's TIF District. Retirement in this account is to abandon a curb stop.

Additions in Account 346 - Meters are for replacement of nearly all of the Utility's meters to implement an automated system. These additions were financed with borrowed funds.

Additions in Account 348 - Hydrants are primarily added by the City's TIF District. A few hydrants were replaced by the Utility during the year.

Accumulated Provision for Depreciation - Water (Page W-10)

Adjustment reported in account 346 represents loss on disposal of meters. This amount has been recorded in account 182 and is being amortized in accordance with PSC authorization dated 3/17/03.

Pumping and Purchased Water Statistics (Page W-12)

Utility purchased no water in 2002, utility does pay an annual fee to Milwaukee Water Works for a stand-by connection (Account 620).

Sources of Water Supply - Statistics (Page W-12)

Note: Ground water is actually raw Lake Michigan water for Industrial customers.
