The payment for the construction costs of the main and subsequent transfer of ownership was transacted through an agreement between WalCoMet and the utility. The construction costs are being amortized over a twenty year period beginning in 1996.

Although there is no commission authorization for amortization of these costs, this accounting treatment was adopted based on the verbal advice of the Commission staff inasmuch as the sewer utility was regulated at that time.
