The primary purpose of the analytical review is to detect possible reporting or accounting related errors and also to identify significant fluctuations from prior years' data that are not sufficiently explained in the annual report. 1. On Page F-18, Account 233, Payables to Municipality, \$21,760 is reported as "payables to municipality." The head note to this schedule requests that amounts greater than \$2,000 be described fully using other than the account title. Please furnish a brief explanation of this amount.

2. On Page F-17, \$900 is reported as contributions for water services. However, no dollar additions are reported to Account 345, Services on Page W-8 and no unit additions are reported on Page W-16. Please furnish an explanation of this \$900 contribution. Who contributed it and what is it for?

Responding to the questions posed from the analytical review does not preclude you from possibly receiving other inquiries from our office regarding your annual report in the future: for instance, during a rate case, construction authorization, or other Commission reviews.
