If an employee works part time for more than one industry then determine FTE based on estimate of hours worked per industry.

Example: An employee worked 35% of their time on electric jobs, 30% on water jobs, 20% on sewer jobs and 15% on municipal nonutility jobs. The FTE by industry would be .4 for electric, .3 for water and .2 for sewer.

The inherent nature of this account can result in large fluctuations from year to year. An analysis of work orders shows decreased activity in this area over the previous year. The 2004 expense of \$45,745 does compare to the previous three year average of \$47,866.

Account #677-Maintenance of Hydrants

Again, the nature of this maintenance account can result in large changes from year to year. The balance in this account has ranged from \$8,868 to \$29,793 over the previous three years.

Account #923-Outside Services Employed

During the previous year, the utility incurred attorney and engineering fees for services related to legal action being taken against a party for nitrate contamination. Attorney fees totaled \$175,340 and engineering fees totaled \$44,770 in 2003. This legal action was settled in 2003 for \$525,000, and consequently the outside services employed account has decreased substantially.

Account #926 Employee Pensions and Benefits

The increase in this account is the result of the allocation to the utility and the subsequent payoff of the utility's share of unfunded retirement liability in the amount of \$120,811.

Property Tax Equivalent (Water) (Page W-07)

If Lower Tax Equivalent authorized by municipality is greater than or equal to zero, please explain.

The municipality has authorized a lower tax equivalent. On May 19, 1998 a resolution was passed by the City Council that eliminated the tax equivalent on the nitrate removal plant. This issue was considered by the PSC and incorporated in the 1998 rate case which was authorized and put into effect on June 1, 1998.

Additions to accounts #314, #321, #325, #332 and #397 relate to the West Well #3 project that was placed into service during 2004. PSC construction authorization was granted in 2003.

If Adjustments for any account are nonzero, please explain.

The adjustment of (\$4,884) in column (i) for Transportation Equipment (#392) is for the gain realized on the sale of unit W-31. All other adjustments relate to the reclassification of pre-2003 historical accumulated depreciation on contributed utility plant per PSC directive.

Water Mains (Page W-21)

If Added During Year column total is greater than zero, please explain financing following the criteria listed in the schedule headnote No. 5.

The utility financed \$49,891 of the mains and the County contributed \$1,413 of the mains.

Explain all reported Adjustments.

Reported adjustments for 6" main relate to the transfer of 1570' from outside the municipality to within the municipality as a result of annexation. The reported adjustments for 12" mains relate to the reclassification of 760' from within municipality category to outside municipality category. This main was added in the year 2000. These reclassifications have been considered in the plant outside of limits in the tax equivalent calculation.

Water Services (Page W-22)

Replacement services are generally financed by the utility. New services were financed utilizing Cz-1 (3 @ \$600).
