We have a test bench and calibration tank in our wellhouse for testing meters up to 3/4" in size. We try to test all of the meters in the village within a 10 year time frame, as they seem to hold their accuracy for at least this long. With the results of these testing and cleaning programs, we feel that the 10 year range could be extended even longer. Our unaccounted for water is well within the guidelines and we attribute a lot of that water that is unaccounted for from unknown underground leaks and water being removed from the system that isn't being reported to us such as fire department, contractors, etc.

Ss. PSC 185.83(2) states "Station meters shall be maintained to ensure reasonable accuracy and shall have the accuracy checked at least once every 2 years." Are all station meters being tested every two years? Answer yes or no. If no, please explain.

Yes, wellhouse meter will be due for testing again in November, 2005.
