Example: An employee worked 35% of their time on electric jobs, 30% on water jobs, 20% on sewer jobs and 15% on municipal nonutility jobs. The FTE by industry would be .4 for electric, .3 for water and .2 for sewer.

Meters are exchanged and tested on a 10 year cycle. Older vintage meters are being junked without testing.

An 8 inch meter was purchased in 2007 and installed in 2008. Therefore there was no need to test.
