5. All dollar amounts will be reported in whole dollars.
6. Wherever information is required to be shown as text, the information shall be shown in the space provided using other than account titles. In each case, the information shall be properly identified. Footnote capability is included in the annual report software program and shall be utilized where necessary to further explain particulars of a schedule.

The water utility has changed their billing periods to end at the end of calendar quarters. In previous years, the utility consistently reported gallons sold through February. In 2008, the utility reports gallons sold through mid-December.

Since gallons sold for the first quarter of 2008 were reported in 2007, gallons sold on page W-2 are only for the remainder of 2008. This overstates unaccounted for water in 2008.

If gallons sold were annualized, unaccounted for water would be approximately 17%. $308,824 / .75 = 411,765 + 7,381 + 3,300 = 422,446$ accounted for water / $511,750$ pumpage = 83%. $1 - 83\% = 17\%$.
