The program will convert the minus sign to parentheses for hard copy annual report purposes. Negative values may not be allowed for certain entries in the annual report due to restrictions contained in the software program.
3. The annual report should be complete in itself in all particulars. Reference to reports of former years should not be made to take the place of required entries except as otherwise specifically authorized.
4. Whenever schedules call for data from the previous year, the data reported must be based upon those shown by the annual report of the previous year or an appropriate explanation given why different data is being reported for the current year. Where available, use an adjustment column.
5. All dollar amounts will be reported in whole dollars.
6. Wherever information is required to be shown as text, the information shall be shown in the space provided using other than account titles. In each case, the information shall be properly identified. Footnote capability is included in the annual report software program and shall be utilized where necessary to further explain particulars of a schedule.

Supplies and Expenses (640) - During 2009 the Water Utility abandoned a well. The Utility did not own the well or the land the well was located on but had incurred costs over the prior years trying to get the well operational. The Utility decided not to amortize these costs but rather directly expense them in 2009 when the well was abandoned. These costs totaled \$16,795.

Repairs of Water Plant (650) - During 2008 the only repairs performed to the water plant were to fix two leaks. During 2009 costs were incurred to locate leaks within the distribution system and \$20,435 was spent for general maintenance on the well pump.

Transportation Expenses (660) - Prior to 2009 the Water Utility did not have a vehicle available for use. During 2009 the Village of Glenbeulah purchased a pickup truck that is used by both the Village and Water Utility. Utility employees log their usage of the truck and the Village is reimbursed for the Utilities usage.
