4. Whenever schedules call for data from the previous year, the data reported must be based upon those shown by the annual report of the previous year or an appropriate explanation given why different data is being reported for the current year. Where available, use an adjustment column.
5. All dollar amounts will be reported in whole dollars.
6. Wherever information is required to be shown as text, the information shall be shown in the space provided using other than account titles. In each case, the information shall be properly identified. Footnote capability is included in the annual report software program and shall be utilized where necessary to further explain particulars of a schedule.

FULL-TIME EMPLOYEES (FTE)

Use FTE numbers where FTE stands for full-time employees or full-time equivalency. FTE can be computed by using total hours worked/2080 hours for a fiscal year. Estimate to the nearest tenth. If an employee works part time for more than one industry then determine FTE based on estimate of hours worked per industry.

Example: An employee worked 35% of their time on electric jobs, 30% on water jobs, 20% on sewer jobs and 15% on municipal nonutility jobs. The FTE by industry would be .4 for electric, .3 for water and .2 for sewer.

Account 630 - In 2008, the utility incurred a lot of work on installing and adjusting a poly system for correcting the "red water" problem. In 2009, labor would have been directed toward other projects. In addition, further work was done to fully automate the chemical treatment process at well # 4 as it was being done manually previously. The automation was completed in 2008 thus the labor for treatment ops decreased in 2009 because of the automation of that process.

Account 631 - Chemicals purchased for the well went up in 2009 because of the rehab of wells #2, #3 which shifted the burden of more water being pulled from well #4 in 2009 necessitating more chemical treatment.

Account 923 - Increased due to engineering costs, costs incurred with the water rate increase and additional legal fees.
