### Focus on Energy Nonprofit Efficiency Accelerator

- A Nonprofit Efficiency Accelerator (NEA) is available to nonprofit organizations.
  There are two paths to participation: the NEA Donation Match (NEA DM) and the
  NEA Request for Proposals (NEA RFP). The NEA DM will provide a donation
  match, in addition to standard incentives, upon completion of an energy efficiency
  project. The NEA RFP allows nonprofits to apply for incentives above standard
  prescriptive and custom rates.
- Businesses must be a 501(c)(3) organization to be eligible for the offering and the
  project site must be served by a participating Focus on Energy utility. Full eligibility

### Department of Energy Low-Income Communities Bonus Credit Program

- DOE recently opened applications for the Low-Income Communities Bonus Credit Program that was established by the Department of Treasury and the Internal Revenue Service (IRS).
- The bonus adds 10 or 20 percentage point increase to the Investment Tax Credit (or Direct Pay) for eligible projects installed on tribal land and/or low income community properties, to increase adoption of and access to renewable energy facilities in underserved and environmental justice communities.
- Interested parties apply for a capacity allocation for each eligible project.
- The deadline to submit applications to Login.gov for the initial application period is

**November 18, 2023 at 12pm EST**. Applications submitted thereafter will be considered based on available capacity allocations remaining.

# U.S. Department of Agriculture Announces \$19.5 Million to Support Rural Communities in Wisconsin

- The U.S. Department of Agriculture recently announced awards for \$19.5 million across three rural initiatives to help farmers adopt new climate-smart agricultural practices, support community infrastructure, and increase economic development.
- Most recent investments in Wisconsin:
  - \$11.92 million across five projects dedicated to rural jobs and infrastructure.
  - \$5 million across 40 projects through the Rural Energy for America Program (REAP)
  - \$2.6 million across 19 projects through the Rural Partners Network.
- REAP loan and grant applications are considered quarterly, with the next deadline of December 31, 2023.

to Rural Wisconsin

- The Office of Energy (OEI) was a part of a first of-its-kind partnership with the community group <u>Couleecap</u> (a local community action agency), <u>Vernon Electric</u> <u>Cooperative</u>, and the <u>Wisconsin Home Energy Assistance Program</u> (WHEAP) in providing funding for the Bluff Prairie Community Solar Farm that will soon start generating power in rural Vernon County.
- OEI provided a grant to cover subscriptions. The credits generated by the panels
  will be distributed to households in the Vernon Electric Cooperative that are lowincome and participating in the WHEAP, the state's Low Income Energy Assistance
  Program.
