

# **State Broadband Expansion Grant Due March 17**

#### **Important Notes for Interested Parties**

The State Broadband Expansion Grant Program aims to deploy high performance broadband in underserved areas of the State. On December 1, 2021 the Commission announced that it is now accepting applications for FY2022 Broadband Expansion Grants. This round will make available \$100 million for grants. Eligible applicants will demonstrate a clear and achievable plan to improve broadband communications services in one or more underserved areas in the State.

Different from previous grant rounds, this round will be funded with bond proceeds authorized by the Wisconsin Building Commission pursuant to Wis. Stat. § 13.48(30). As such, successful applicants are subject to the requirements of Wis. Stat. § 13.48(30).

The Commission has added additional information and a draft grant agreement to the Broadband Grants website for applicants to understand this change.

DRAFT Grant Agreement FY2022 - Bonding

Since the opening of the grant round, the Wisconsin Broadband Office has hosted a number of webinars, including a grant overview and how to map your broadband project. The webinars are available to view on the <u>Broadband grant website</u> and serve as an excellent resource for applicants.

February 15, 2022 was the last day for submitting questions and requests for clarification on the application. The Commission has added a <u>Frequently Asked Questions document</u> to the grant website that provides additional information and answers to submitted questions.

On February 22, 2022 the <u>Wisconsin Broadband Map</u> was updated to reflect the results of the most recent data collection and data submitted to the FCC. Applicants should make sure to use the most up-to-date version of the map when submitting their application.

# **Request for Comment on Middle Mile**

#### Public Service Commission of Wisconsin Requesting Comments on Middle Mile

The Commission is committed to expanding broadband service in unserved and underserved areas of the state. To assist in the deployment of expanded service, the Commission directed staff to investigate how to best support and coordinate the construction of middle mile fiber routes, and prepare informational recommendations for the Commission. The Commission requests comments from interested parties on the topic of construction of middle mile broadband infrastructure. The Commission is interested in how to evaluate middle mile proposals in grant programs and also how to structure the grant awards to best reinforce existing routes or build out new middle mile routes to reach areas that currently have inadequate broadband service.

## **Federal Broadband Updates**

#### **Bipartisan Infrastructure Law**

The White House has released a "Guidebook to the Bipartisan Infrastructure Law for State, Local, Tribal, and Territorial Governments, and Other Partners." The guidebook provides a nice overview of each broadband related program in the law including brief descriptions and eligible uses for each program. The broadband section begins on page 385.

#### **USDA ReConnect Program**

The U.S. Department of Agriculture's (USDA) Rural Utilities Service (RUS) announced more than \$1 billion in funding to promote broadband access in rural, Tribal and socially vulnerable communities through the <u>ReConnect program</u>. The program will offer eligible recipients a mix of grants, grants and loans combined and loans only to support the construction, improvement, or acquisition of facilities and equipment to deploy robust, high performance broadband capable of 100/100 Mbps.

Applications are open and the deadline has been extended to March 9, 2022.

#### FCC Rural Digital Opportunity Fund (RDOF) Funding Authorizations

The FCC continues to review long-form applications of winning bidders in the RDOF Auction 904 on a rolling basis. As of February 14, 2022 the following winners have been authorized for funding in Wisconsin: Baldwin Telecom, Inc., Bruce Telephone Company, Inc., Cuba City Telephone Exchange Co., La Valle Telephone Cooperative, Inc., Lakeland Communications Group, LLC, Richland-Grant Telephone Cooperative, Inc., and Somerset Telephone Co. Inc.

The following winners are ready to authorize in Wisconsin: Charter Fiberlink CCO, LLC; Marquette-Adams Telephone Cooperative, Inc.; and Reedsburg Utility Commission.

#### **Emergency Connectivity Fund**

The FCC continues to review and approve <a href="Emergency Connectivity Fund">Emergency Connectivity Fund</a> applications. Schools and libraries in Wisconsin have requested \$82,990,397. As of February 23, 2022 \$70,774,613 has been approved. More than \$12 million in Wisconsin requests are still pending review. The FCC has extended the deadline to use committed ECF funds to June 30, 2023. Across the nation, total commitment to date will support over 11,000 schools, 900 libraries and 130 consortia for over 10 million connected devices and over 5 million broadband connections.

#### **NTIA Tribal Connectivity Program**

The National Telecommunications and Information Administration (NTIA) has made 8 Tribal Connectivity awards as of February 22, 2022. Two of the eight awards impact Wisconsin. Lac Courte Oreilles, Stone Lake, \$442,734 The proposed planning study will complete a detailed feasibility analysis and broadband design to determine the best way to provide broadband services to its government facilities, business enterprises, and its unserved housing units located on the Reservation. Sokaogon Chippewa, Crandon, \$452,162 The Broadband Use and Adoption project will cover the costs of broadband internet services for all Mole Lake Reservation households (approximately 500 Tribal members), including upgrades to service (faster connections) and new modems and routers as needed.

## **Affordable Connectivity Program Resources**

The Public Service Commission is working to help build awareness about the <u>Affordable Connectivity Program</u>, a Federal Communications Commission (FCC) program. The new long-term benefit will help to lower the cost of broadband service for eligible households struggling to afford internet service.

The \$14 billion Affordable Connectivity Program provides a discount of up to a \$30 per

month toward broadband service for eligible households and up to \$75 per month for qualifying households on qualifying Tribal lands. The benefit also provides up to a \$100 per household discount toward a one-time purchase of a computer, laptop, or tablet if the household contributes more than \$10 and less than \$50 toward the purchase through a participating broadband provider.

As of February 22, 2022 Wisconsin has 177,892 households enrolled in the program. The FCC has developed an <u>Outreach Toolkit</u> for organizations to use in promoting the program. # **Digital Equity and Inclusion Updates**

#### **Nonprofit Access Grant Program**

The program enables nonprofit groups to apply for partial funding of programs or projects that will facilitate affordable access to telecommunications and digital inclusion activities. The project must assist low-income households, people with disabilities or customers in areas of the state that have relatively high costs of services in obtaining affordable access to a basic set of essential telecommunications services. The Commission may award up to \$500,000 in grants under this program on a fiscal year basis.

#### National Digital Inclusion Alliance - Digital Navigator Corp Opportunity

National Digital Inclusion Alliance (NDIA) received a multi-million grant to create a Digital Navigator Corps. The funding will be used to build and advance local digital inclusion work and to strengthen the digital equity model in *rural and Tribal communities*. Digital Navigators are trusted guides who assist community members in internet adoption and the use of computing devices. NDIA will partner with 18 sites, including a minimum of six sites in Tribal communities and Indian Country. These sites will get our support and funding in launching multi-year digital navigator programs – including in training, outreach, and data collection

# Grant Recipient Corner: State Broadband Grants Project Status Reports

All <u>State</u> grant Agreements require recipients to file periodic project status reports, either an <u>interim</u> or a <u>final</u> report. Most grant recipients will file multiple interim reports and all grantees should file only one final report for each project. This article is about those interim and final reports, as there is some confusion over the final report.



Interim reports are due periodically throughout the performance period defined in your grant Agreement. Refer to your Agreement for details on *when* to file your interim reports (and final reports too).

Applicants define a project schedule in their application. File your final project status report and email your final payment request when you reach those project milestones and know the final project expenses. Sometimes a recipient incurs all budgeted project expenses before meeting all scheduled milestones. In these cases, recipients can send a payment request to draw down all available grant funds. However, we only release the amount of funds provided for in your grant Agreement (up to 90% of grant funds for some awards, 80% for others).

Remember to file all project status reports on <u>ERF</u>, the Commission's electronic records filing system. If you have any questions about project status reports, please contact <u>Dennis Klaila</u>.

### Grant Recipient: Best Practice for Tracking Property

As a best practice, and to facilitate proper tracking of property,

recipients should tag any piece of equipment (including supplies such as computing devices that are attractive due to their use of potential value and easily pilferable due to their size). Tags should consist of a physical label with an inventory number and should not be easy to remove. The tag should also indicate the funding source (i.e., the federal or state program name) and name of the entity that holds the title to the property.
