

Wisconsin Joins National "Internet For All" Initiative

Last week, Governor Tony Evers and the U.S. Department of Commerce's National Telecommunications and Information Administration (NTIA) announced that Wisconsin has signed on to participate in the "Internet for All" initiative, which will invest \$65 billion to provide affordable, reliable, high-speed internet for everyone in America by the end of the decade.

Funded through the Bipartisan Infrastructure Law and administered by NTIA, the Internet for All programs will build internet infrastructure, teach digital skills, and provide necessary technology to ensure that everyone in America – including communities of color, rural communities, and older Americans – have the access and skills they need to fully participate in today's society.

The Internet for All programs launched with three Notices of Funding Opportunities:

- Broadband Equity, Access, and Deployment (BEAD) Program (\$42.5 billion);
- Enabling Middle Mile Broadband Infrastructure Program (\$1 billion); and,
- State Digital Equity Act programs (\$1.5 billion).

To participate in the BEAD Program, Wisconsin has submitted a letter of intent and a planning funds request, which will unlock up to \$5 million in planning funds and allow Wisconsin to begin creating its five-year action plan. Each participating state is guaranteed a minimum \$100 million allocation, with additional funding determinations made based on the forthcoming coverage maps from the Federal Communications Commission.

PSC Awards Nonprofit and Telemedicine Grants

Commission Awards \$500,000 in Nonprofit Access Grants for 16 Projects
The funds will go to support 16 projects by 501(c)(3) nonprofit organizations that will provide access to affordable telecommunication services to low-income households, people with disabilities, or customers in areas of the state with relatively high costs of services.

"Access to affordable and reliable telecommunications services is extremely important," said PSC Chairperson Rebecca Cameron Valcq. "These nonprofit organizations will work in their communities to connect some of our most vulnerable populations with critically needed phone service, data plans, Wi-Fi, loaned devices, computer labs, and specialized telecommunications equipment for Wisconsinites with disabilities." Commission Awards more than \$790,000 in Telemedicine Grants for 12 Projects The funds will support 12 projects that will purchase medical telecommunications equipment to enhance access to medical care in rural or underserved areas.

"The projects funded today use broadband and telecommunications services to reduce barriers to getting necessary health screenings as well as decrease the time to access emergency or specialized care for our most vulnerable communities," said PSC Chairperson Rebecca Cameron Valcq. Federal Broadband Updates

Broadband Equity, Access, and Deployment (BEAD) Program

Funded by the Bipartisan Infrastructure Law, BEAD is a federal grant program that aims to get all Americans access to affordable, high speed internet. The BEAD program is administered through states, and in Wisconsin the Public Service Commission will serve

as the program coordinator. BEAD prioritizes unserved locations that have no access or access under 25/3 Mbps, and then underserved locations without access to 100/20 Mbps and finally to community anchor institutions.

Enabling Middle Mile Broadband Infrastructure Program

The new <u>middle mile program</u> will provide \$1 billion in funding for the construction, improvement, or acquisition of middle mile infrastructure, and to reduce the cost of connecting unserved and underserved areas of the country. Governments, industry, non-profits and partnerships are among the eligible entities to apply.

Broadband Office Launches Internet Self Report



The Wisconsin Broadband Office recently developed a survey to gather information on the internet experience of Wisconsin residents. The survey will collect information on internet speed, affordability, device use, satisfaction and performance. The survey will be used to gather data on the internet in Wisconsin over time and track our progress towards affordable, high performance broadband for all.

In June, the Commission will add a phone number and call in opportunity for individuals unable to take the survey online.

Digital Equity and Inclusion Updates

Get Internet Website Launching

The Affordable Connectivity Program (ACP) provides eligible households \$30 per month off their internet bills. To deliver maximum cost savings to families, the Biden-Harris Administration has secured commitments from over 20 leading internet providers to offer ACP-eligible households a high-speed internet plan for no more than \$30 per month. Eligible families who pair their ACP benefit with one of these plans can now receive highspeed internet at no cost. The Administration is launching a new website getinternet.gov to assist households to find a no cost offer.

Digital Equity Act (DEA) Programs

Funded by the Bipartisan Infrastructure Law, DEA Programs are planning and implementation programs that provide funding to promote digital inclusion and advance equity. The three programs include two state formula programs and one competitive program. The first state formula grant will be to develop a State Digital Equity Plan and the following grant will be to implement the plan.

State of Digital Equity & Using Data to Advance Digital Skills

EveryoneOn released their final report in the 3-report series on digital connectivity during the pandemic. The State of Digital Equity: Lessons from survey data and focus groups was published in partnership with John B. Horrigan, PhD and explores the persistent barriers to internet adoption. The report may be used to develop initiatives that foster digital equity.
