

## **Broadband Expansion Grant Round Announced**

Governor Tony Evers and Rebecca Cameron Valcq, Chairperson of the Public Service Commission of Wisconsin (PSC), announced the next round of funding opportunities through the State Broadband Expansion Grant Program. The application period runs from December 7, 2022 through February 22, 2023 at 1:30 pm CT.

In this grant round, \$14.1 million is available to applicants to help expand high-speed broadband Internet in the state through funding from the Universal Service Fund. These are the remaining state funds available for broadband expansion during the 2021-23 biennial budget period.

The application process for this grant round will have a new look. The PSC has developed an on-line application system to submit grant applications. The Commission has adopted the grants system to streamline the application process, produce grant applications that better respond to the questions, and provide applicants with better confidence that their submission meets the filing requirements for this grant cycle. PSC staff want this new application format to work well, and will provide a webinar and assistance on the grants system. An applicant in the FY 2023 grant cycle is required to submit the application using the new online PSC Grants System. 

FY2023 State Broadband Expansion Grant application is in the docket 5-BF-2023. Interested parties must proactively subscribe to the docket on the Commission's <u>ERF</u> system to ensure they receive timely information related to the process.

### Help improve the National Broadband Map



In November, the Federal Communications Commission (FCC) unveiled the preproduction draft of the new national broadband map. The new map is the most granular and up to date federal map of where broadband is and is not available across the country.

The FCC is seeking help to improve the data on the map by asking communities and individuals to submit a challenge or request a correction. The FCC has recently published a <u>National Broadband Map Outreach Toolkit</u> with materials that are available for public use. The Broadband Office encourages Wisconsin residents to check the map and submit a challenge in cases where the map is not accurate.

The FCC's new broadband maps will be used to determine the allocation of Broadband Equity, Access and Deployment (BEAD) funds that Wisconsin will receive. An accurate map is critical to ensure Wisconsin receives our fair share of federal funding. To ensure valid challenges are incorporated into the map before federal funding allocations are made, the public are encouraged to **submit challenges by January 13, 2023**. Please spread the word.

# **Digital Equity and Inclusion Updates**

#### FCC Affordable Connectivity Program Competitive Outreach Grants Due Jan. 9

On November 10th, the Federal Communications Commission released a Notice of Funding Opportunity (NOFO), a formal announcement of the availability of grant funds to develop innovative outreach strategies to reach historically underserved and unserved communities, raise awareness of the Affordable Connectivity Program (ACP), and help eligible individuals enroll in the program. The FCC has set aside up to \$70 million in the NOFO for these two programs, \$60 million for the National Competitive Outreach Program and \$10 million for the Tribal Community Outreach Program. The grant program could support in-person enrollment assistance, digital campaigns, outreach materials, direct
