Internet for All Wisconsin Listening Tour Announced



Gov. Evers, together with the Public Service Commission of Wisconsin (PSC), announced the statewide <u>Internet for All Wisconsin Listening Tour</u>, a series of nine in-person and two virtual interactive meetings to help develop the state's five-year action plan to deploy high-speed internet and improve internet affordability and adoption.

Community leaders and all interested members of the public are welcome to attend this free event. Prospective attendees are advised to visit the listening tour webpage for additional event information as it becomes available.

Wisconsin could expect an allocation of \$800 million to \$1.1 billion to implement the state's five-year action plan for broadband and approximately \$25 million to implement the state's Digital Equity Plan under the Bipartisan Infrastructure Law's 'Internet for All' programs. In December 2022, Gov. Tony Evers and the PSC announced the nearly \$6 million federal investment for the state to develop these plans by gathering local input from Wisconsinites in broadband access and digital inclusion activities.

The Internet for All Wisconsin Listening Tour is hosted by the PSC's Wisconsin Broadband Office, in partnership with Wisconsin's nine regional economic development organizations. If someone is unable to attend an in-person or virtual meeting, they may still submit public comment <u>here</u>.

Listening Tour

PSC Awards over \$1.9 Million in "Internet for All" Planning Grants

The Public Service Commission of Wisconsin (PSC or Commission) awarded 44 grants under the Bipartisan Infrastructure Law's 'Internet for All' Initiative, including the Broadband Equity, Access and Deployment (BEAD) Workforce Planning Program, Digital Equity Outreach Program and BEAD Local Planning Grants.

These grant programs will inform and prepare for the next stages of the 'Internet for All' timeline. Wisconsin could expect an allocation of \$800 million to \$1.1 billion to implement these plans under BEAD and additional federal funding will help to implement the state's digital equity plan so that all residents have access to a reliable, affordable internet connection.

The Commission made awards to two entities totaling \$100,000 under the BEAD Workforce Planning Grant Program. This program is designed to engage existing entities involved in workforce development–including industry groups, labor organizations, and technical colleges–to plan workforce development strategies, in preparation for BEAD funding and to ensure all Wisconsinites have a pathway to these career opportunities. The Commission made awards to seven entities totaling \$335,000 under the Digital Equity Outreach Grant. Digital Equity Outreach activities may include but are not limited to interactive workshops, surveys, townhall discussions, data collection, and interviews with covered populations. The information collected from successful applicants will inform the statewide digital equity plan. The list of Digital Equity Outreach awards is <u>here.</u>

The Commission approved a \$1.5 million formula grant to support local broadband planning efforts and build local capacity for counties, Tribes and Regional Economic Development Organization. All 72 Wisconsin counties and five Tribes opted into the formula grant, with 48 of these entities collaborating through one of six participating Regional Economic Development Organizations with a total of 35 awards allocated. Federal Broadband Updates

USDA Offers Funding to Promote Internet Planning and Expansion in Rural Areas

The USDA announced \$20 million in available funding under the new Broadband Technical Assistance Program. The program supports technical assistance projects such as conducting feasibility studies, completing network designs and developing broadband financial assistance applications. **The application deadline is June 19**. Comment Period on BEAD Program State Challenge Process

NTIA released proposed guidance for the BEAD program's state challenge process. The program's rules require that each state and territory administer a "challenge process." In the challenge process a unit of local government, nonprofit organization, or ISP may challenge whether a location or community anchor institution is eligible for BEAD funding, including whether a location has limited or no Internet service. The proposed guidance expands upon previous guidance to assist states and includes a model challenge process. To submit a comment email BEAD@ntia.gov by midnight on May 5, 2023.

Oneida Nation Awarded \$500,000 from Tribal Broadband Connectivity Program

The Department of Commerce's National Telecommunications and Information Administration (NTIA) has awarded \$498,217 to the Oneida Nation as part of the <u>Tribal</u> <u>Broadband Connectivity Program</u> (TBCP). This Broadband Infrastructure Deployment project will construct a fiber backbone to enable the Oneida Nation to reach future locations with fiber for expanding broadband capabilities on the reservation.

Digital Equity and Inclusion Updates

Digital Equity Act Request for Comment

NTIA is <u>requesting comments</u> on the \$2.75 billion Digital Equity Act of 2021 Program, and on the design and implementation of two components of that grant program: the \$1.44 billion State Digital Equity Capacity Grant Program and the \$1.25 billion Digital Equity

Competitive Grant Program. NTIA seeks broad input and feedback from all interested stakeholders across the nation, including Tribal entities. The public comment will be used to improve the number and quality of ideas under consideration as the agency develops the Notice of Funding Opportunity. <u>Comments are due on or before 5 p.m. E.T. May 1, 2023.</u>

Invitation to help identify digital equity barriers and opportunities

The PSC continues to work to identify barriers to the digital equity and skill development needs of Wisconsinites. Identifying these barriers is part of data collection and development of the Wisconsin Digital Equity Plan, which is required by the Federal Bipartisan Infrastructure Law. BEAD Local Planning Grant Application Due May 1st

Reminder: the <u>Broadband Equity</u>, <u>Access</u>, <u>and Deployment (BEAD) Local Planning Grant</u> is still accepting applications <u>per the award letter</u>. Applications from the entities listed in the award letter are due by **May 1st**, **2023 at 1:30 p.m**. Awardees listed in the letter must submit their application via the <u>PSC Grants System</u>.

In order to enter into a grant agreement and access the grant funds, recipients **must** submit a simple grant application through the PSC Grants System. Please refer to the <u>PSC Grants System User Guide</u> for guidance on how to use the system. Commission staff are on hand to provide technical assistance throughout this process. Digital Equity Outreach and Impacts

Closing the Digital Skills Divide

National Skills Coalition (NSC) in partnership with the Federal Reserve Bank of Atlanta released *Closing the Digital Skill Divide*, a real-time snapshot of demand for digital skills in the US labor market. The analysis finds that 92% of jobs analyzed require digital skills. Previous NSC research found one-third of workers don't have the foundational digital skills necessary to enter and thrive in today's jobs. Together, these findings point to a significant digital skill divide. This report also found that public investments in closing this digital skill divide can generate measurable economic payoff for businesses, workers, and the broader economy.

Broadband Grant Recipients Press Releases and Marketing Materials Reminder

Refer to your FY22 and forward grant agreements for advertising requirements. An example of required language follows, but always consult your specific grant agreement for updates or any federally-required language.

"This project [is being] [was supported, in whole or in part, through \$[grant award amount] of funds from the State of Wisconsin, acting by and through the Public Service Commission of Wisconsin."

This agreement requirement (1) remains in effect long after the performance period ends and (2) requires sufficient advance notice to the Commission which provides our State opportunity to participate. There are a few other important requirements. Please refer to section 24 of your federally funded ARPA agreements or section 31 of FY22 stateside grant agreements.

State-Funded Broadband Expansion Grants

Project Status Reports: Interim Reports are Due by April 30

Updated Project Status Report forms are on our <u>State Broadband Grant webpage</u>. When preparing your reports, always use the version currently posted on our webpage. The forms contain changes to help inform the Commission and the public about your projects as well as to help Recipients stay in compliance with grant agreements and speed up the reimbursement process.

<u>Interim project status reports</u> for all open grants are due during the month of April, unless a final reimbursement request is submitted on or before that date. Interim Reports must be filed no later than April 30.

<u>Final project status reports</u> are required for all completed projects (i.e., all deliverables have been met), and all final reimbursement requests require the filing of a final project status report.

Upload your reports to <u>ERF</u>, the Commission's Electronic Records Filing System that provides public access to information about awarded projects, etc. Send all state grant reimbursement requests to <u>PSCBroadbandGrantReimbursement@Wisconsin.gov</u> and final project spatial data to <u>PSCBroadbandData@wisconsin.gov</u>. When uploading to ERF or emailing about a project, please include "*Award UID*, BBEG FY20XX *GranteeKeyword(s), ProjectKeyword(s)*" which can be found on your customized reimbursement forms. Be sure to upload your report to the correct docket [5-BF-20XX].
