

# **Governor's Task Force Report Released**

Gov. Tony Evers announced the release of the Governor's Task Force on Broadband Access' third annual report. Building upon findings from the previous two reports, the 2023 report provides an update on efforts to expand access, adoption, and affordability of highspeed internet across the state. The third annual report makes recommendations for the state to continue building on this progress and prepare to capitalize on increased federal investments through the 'Internet for All' initiative under President Joe Biden's Bipartisan Infrastructure Law (BIL).

The 2023 report provides several recommendations to ensure the state continues building upon Gov. Evers' and the Evers Administration's progress expanding access to reliable, high-speed internet, including:

- Support local communities through technical assistance efforts and ensure their involvement and participation in the rollout of federal funds;
- Ensure a sufficient and trained telecommunications workforce for internet service providers, contractors, and subcontractors to construct, operate, and maintain current and new broadband infrastructure;
- Improve mapping and data efforts by supporting local communities in their efforts to pursue, collect, and make meaning of local data; and
- Continue outreach and promotion of the Affordable Connectivity Program (ACP) to reach the highest possible levels of participation in Wisconsin.

Since its inception, the Task Force has brought together a diverse group of members with experience in this field to learn from outside experts, hear from the public, and identify forward-looking broadband policies and initiatives that aim to close the digital divide in the state.

# State Launches New Tool to Help Wisconsinites Find Free, Discounted Internet Service

Gov. Tony Evers together with the Public Service Commission of Wisconsin (PSC) and the Wisconsin Department of Public Instruction (DPI), announced the launch of the Internet Discount Finder website to help Wisconsin households find and access affordable internet. The new tool can assist in finding free and discounted internet service available to eligible Wisconsin residents. The Internet Discount Finder guickly matches eligible Wisconsin residents to low-cost home internet service and discount programs by entering their address and identifying their eligibility criteria. The tool will show available plans and describe next steps for enrollment in the Affordable Connectivity Program (ACP). The ACP helps eligible households get a discount of up to \$30 per month for broadband

# **New \$42 Million Broadband Grant Program**

Gov. Tony Evers, together with the Public Service Commission of Wisconsin (PSC), announced the Broadband Infrastructure Program application period will begin August 14,

2023. Under the American Rescue Plan Act (ARPA), the U.S. Department of Treasury awarded Wisconsin \$42 million through the Capital Projects Fund (CPF) to administer the Broadband Infrastructure Program and invest in projects that will provide high-quality internet to locations that lack access to adequate, affordable service.

Eligible entities for the competitive grant program include internet service providers, telecommunications utilities, cooperatives, local governments, and for-profit and non-profit organizations. The funding is available to construct broadband infrastructure projects to deploy reliable internet service that will meet or exceed 100/100 megabits per second (Mbps) symmetrical speed internet service and include at least one low-cost option for work, education, and health monitoring.

On August 14th, more information about the upcoming grant application will be made available by the PSC's Wisconsin Broadband Office. The deadline to apply will be in November 2023. The Commission docket for the Capital Project Fund Broadband Infrastructure Grant Program is 5-CPF-2023. 

# **Federal Program Updates**

### NTIA Request for Comment BEAD Program Uniform Guidance

NTIA is requesting comment related to Uniform Guidance in the BEAD Program through a

<u>request for comment</u> period which ends August 4<sup>th</sup>. This is an opportunity for stakeholders to let NTIA know what exemptions from Uniform Guidance may assist with implementation of the program. Stakeholder feedback is important as it will contribute to decisions about retaining program profit, type of sub-awards which could reduce administrative burdens, procurement requirements such as requests for bids, and property and equipment protocols. ### FCC Issues Enhanced A-CAM Order

On July 24, 2023 the FCC issued an order to extend its Alternative Connect America Model (A-CAM) funding and to increase the speed requirements for participating providers. ISPs that accept enhanced A-CAM must now be able to deploy broadband speeds of at least 100/20 Mbps to 100% of eligible locations. Wisconsin is among the top five states in the nation for A-CAM locations. Here is a downloadable <u>fact sheet from the FCC</u>.

### **Tribal Broadband Connectivity Program Award**

The National Telecommunications and Information Administration (NTIA) has announced an award for another award for a tribal community in Wisconsin. The Menominee Indian Tribe of Wisconsin was awarded \$500,000 to deploy a middle-mile and fiber to the home network to increase access to rural broadband on the Menominee Indian Reservation.

### **Enabling Middle Mile Broadband Infrastructure Award**


The National Telecommunication and Information Administration announced awards for to expand middle mile high-speed internet in June 2023. In Wisconsin, Dairyland Power Cooperative was awarded \$14.9 million for the Tri-State Fiber Deployment Project in Wisconsin, Minnesota and Iowa. The project will retrofit 240 miles of fiber on transmission lines, and last mile providers in these regions will have enhanced capacity to reach unserved and underserved residents using the facilities.

# **Wisconsin Internet for All - BEAD Allocation**

On Monday, June 26th, President Biden announced how the federal government will allocate funding to all 50 states, the District of Columbia and the territories to deploy affordable, reliable, high-speed internet service to everyone in America. Wisconsin is receiving **\$1,055,823,573.71** in federal funds through the Broadband Equity Access and Deployment (BEAD) program.
