

# Capital Project Fund Broadband Infrastructure Program Accepting Grant Applications

The Commission is currently accepting applications for the Capital Projects Fund Broadband Program. Under the American Rescue Plan Act (ARPA), the U.S. Department of Treasury awarded Wisconsin \$42 million through the Capital Projects Fund (CPF) to administer the Broadband Infrastructure Program and invest in projects that will provide high-quality internet to locations that lack access to adequate, affordable service.

The funding is available to construct broadband infrastructure projects to deploy reliable internet service that will meet or exceed 100/100 megabits per second (Mbps) symmetrical speed internet service and include at least one low-cost option for work, education, and health monitoring.

The Commission docket for the Capital Project Fund Broadband Infrastructure Grant Program is 5-CPF-2023. # Broadband Equity, Access, and Deployment 5 - Year Plan Submitted to NTIA



Wisconsin has submitted the Five - Year Action Plan that establishes the State's broadband goals and priorities to NTIA for the purposes of implementing Internet for All. The plan serves as a foundational guide for the deployment of the BEAD funding to ensure Internet for All Wisconsin.

The required Five-Year Plan is the result of

comprehensive and robust outreach, local coordination, Tribal consultation and survey responses along with data on broadband access, affordability and adoption. The plan has been submitted and will be finalized upon review and approval by NTIA. Following the Action plan the Commission will be working on volume one and volume two of the BEAD initial proposal. The Initial Proposal will provide additional detail on the implementation details of the BEAD program and will go out for public comment. The Initial proposal is due by December 27, 2023. The docket for the BEAD and Digital Equity planning processes is

# Maximize the Impact of BEAD Funding: Planning and Partnering Towards Internet for All Workshops



UW Extension has announced that registration for four regional broadband workshops is now open. *Maximize the Impact of BEAD Funding: Planning and Partnering Toward Internet for All* workshops are being organized by UW- Madison, Division of Extension's Community Development Institute in partnership with Wisconsin Counties Association, Wisconsin Broadband Office, Wisconsin Economic Development Corporation, Wisconsin State Telecommunication Association and Northwood Technical College.

The goal of the 2-day workshops is to help counties best prepare to access BEAD funding through planning and partnering. Wisconsin Counties Association President and CEO Mark O'Connell will address the role of County Government in Broadband. Staff from the National Telecommunications and Information Administration and the Wisconsin Broadband Office will explain timelines and next steps for BEAD and DE (Digital Equity) funding. Extension staff will provide resources on broadband economics, developing public private partnerships, planning tools and financing options for communities. Legal staff from WCA will discuss considerations counties should make when entering broadband partnerships and resources available through the association. UW Extension is working to secure Internet Service Providers for the second day of the workshops for county consultations.

Attending regional workshops is an allowable expense through your BEAD planning grant. The four 2-day regional workshops will be held:

- September 6-7, Northwood Technical College in Rice Lake
- September 28-29, Cranberry Country Lodge in Tomah
- October 9-10, Radisson Hotel in Fond du Lac
- October 25-26, Nicolet College in Rhinelander

As part of the registration process teams will be asked which internet service providers you would be interested in having a conversation with.

## **Federal Program Updates**

### NTIA Request for Comment BEAD Build America, Buy America Guidance

The Department of Commerce is accepting public comments on a proposal to issue a limited, general applicability, nonavailability waiver of the Buy America Domestic Content Procurement Preference (Buy America Preference) to recipients of Federal financial assistance under NTIA's BEAD Program, which will flow down to subrecipients. Comments on the proposed waiver are due September 21, 2023. <u>More information</u>.

#### **USDA Awards ReConnect Loan in Wisconsin**

On August 21, 2023, the USDA announced a \$28 million ReConnect Loan to Reedsburg Utility Commission to provide reliable, affordable high-speed internet to nearly 10,000 people in Southwest Wisconsin. Here is the press release from USDA.

### **Tribal Broadband Connectivity Program Accepting Applications**

NTIA announced the availability of nearly \$1 billion in funding to expand Internet access and adoption on Tribal Lands. This second round of funding from the Internet for All initiative's Tribal Broadband Connectivity Program (TBCP) will make up to approximately \$980 million available for Native American, Alaska Native and Native Hawaiian communities for the deployment of Internet infrastructure on Tribal Lands, affordability programs, telehealth and distance learning initiatives. ### **RDOF Withdraw in Wisconsin**

The FCC announced that Cuba City Telephone Exchange Co. has notified the Commission of their decisions to withdraw from the Rural Digital Opportunity Fund (RDOF) support program. Cuba City was awarded over \$500,000 in support to serve 302 locations. The FCC considers these locations to be defaulted. <u>See the FCC announcement</u>.
