

# Digital Connectivity and Navigator Grant Instruction Updates, FAQ and Deadline Extended

The Commission recently <u>amended the application instructions</u> for the Capital Projects Fund Digital Connectivity and Navigators Grant Program and extended the deadline by two weeks until July 3. Under the American Rescue Plan (ARPA), the U.S. Department of the Treasury allocated \$33 million to Wisconsin for the grant program. The Program is for projects that promote digital connectivity by deploying devices - such as computers, laptops, and tablets for eligible households to access. The program also promotes digital connectivity through the installation of Wi-Fi equipment in eligible multi-dwelling unit buildings, which includes apartment buildings, condominiums, and mobile home parks. Both approaches will include the provision of digital navigation services to ensure Wisconsinites can make full use of the internet for work, education, health monitoring, and other essential activities.

The Commission has posted <u>amended application instructions</u>, an <u>Application Question</u> <u>Table</u> document, and the <u>new Frequently Asked Questions</u> document to the docket.

The application deadline has been extended to July 3, 2024 by 1:30 p.m.

# Wisconsin BEAD Program Updates

The Broadband Equity, Access, and Deployment (BEAD) Program was created under the Bipartisan Infrastructure Law (BIL), in order to provide access to reliable, affordable high-speed internet. The BEAD program allocates \$1,055,823,573.51 to Wisconsin.

#### Internet for All Wisconsin Plan Published

Throughout 2023 and into early 2024, the Commission engaged in robust and comprehensive outreach, data collection, and planning to develop two federally required plans for Internet for All:

- The Five-Year Action Plan establishes the State's broadband goals and priorities and the Digital Equity Plan establishes the digital equity goals, values, and measurable objectives for the State.
- The Commission has created a single executive summary of both plans together in the Internet for All Wisconsin Plan. See the Internet for All Wisconsin Plan.

#### **BEAD Challenge Process Update**

In April Wisconsin BEAD Initial Proposal Volume 1 was approved and the BEAD Challenge process began. The BEAD Challenge window closed on May 29th at 1:30 p.m. CT. WBO staff will review submitted challenges, update the BEAD Challenge Map and then open a 30-day window for the rebuttal period. For BEAD challenge-related questions, eligible participants should review the new <u>WI BEAD Challenge Process Frequently Asked Questions (FAQs) document</u>. Providers should review the <u>BEAD Challenge Provider Contact List</u> to ensure the Broadband Office has the correct primary contact for challenge communication, particularly for sending challenges to the provider for the opportunity to rebut. Thank you to the hundreds of partners, local officials, broadband champions and internet service providers that attended one of the nine BEAD Funding: Permitting, Engagement and Learning from Experience Workshops. While the workshops are complete the <u>resources</u> are available online.

#### **Other BEAD Resources**

In January NTIA released guidance on <u>Reliable Broadband Service & Alternative Technologies</u>. The guidance provides information on types of technologies and their degree of prioritization for BEAD funding.

In March, NTIA launched a <u>new mapping tool</u>, the <u>Permitting and Environmental Information</u> <u>Application</u>, to help potential BEAD grant recipients and others deploying infrastructure identify permit requirements and avoid potential environmental impacts.

The Commission has opened the docket that will be used for BEAD implementation. The BEAD program docket is <u>5-BD-2025</u> and interested parties should subscribe to the docket to ensure they receive the all communications within the docket.



# **Federal Broadband Updates**

#### **Rural Digital Opportunity Fund Defaults Impact Wisconsin**

On May 1, 2024, the Federal Communications Commission (FCC) confirmed receipt of a letter from Charter Fiberlink CCO LLC ("Charter") indicating they will not fulfill their Rural Digital Opportunity Fund (RDOF) obligation for 57 Census Block Groups (CBGs) in Wisconsin, impacting 11,101 locations. On May 10, 2024, the FCC's Wireline Competition Bureau issued an <u>announcement</u> confirming the affected 57 CBGs that will no longer be constructed using RDOF funding and no longer have a RDOF enforceable funding commitment. The Commission of Wisconsin <u>posted a table and map</u> of the impacted locations in Wisconsin.

#### Affordable Connectivity Program Wind Down and Final Payment

The Affordable Connectivity Program (ACP) stopped accepting new applications and enrollments on February 7, 2024. The last fully funded month of the program was April 2024. In May, partial payments were available. At this time, the program is expected to end. Impacted households and stakeholders can find wind-down resources here and consumer resources here.

#### FCC Net Neutrality / Title II Order Published

On April 25, 2024, the Federal Communications Commission adopted a Declaratory Ruling, Order, Report and Order, and Order on Reconsideration (Order) restoring Net Neutrality and bringing back a national standard for broadband reliability, security, and consumer protection. On May 22, 2024, a notice was published in the Federal Register establishing an effective date of July 22, 2024, for these rules. 
## What ISPs Need to Know About the FCC's Title II / Open Internet Order

# **Grant Recipient Corner**

## Project-Related Expenses, Exclusive Grant Funding

Successful grant management requires attention to details in your grant agreement (GA), in particular managing the project scope and staying within the budget. Key to this is tracking and reporting of project-specific expenses and maintaining exclusive funding provisions.

To be reimbursable or qualify as match, all expenses must be*directly attributable* to the grant project defined in the GA. Grantees should have proper tracking systems in place to ensure accurate reporting of grant expenses and retain records for periods outlined in the GA.

Grant awards are exclusive funding and funds must be used only for the project defined in the GA. The GAs defines the approved project scope and budget. Scopes cannot be changed without the Commission's prior approval; budget changes also require prior approval. Refer to the GA for details.

And remember, only invoices that have been fully paid may be claimed for reimbursement.
