<u>2</u> Including companies which have been recertified by the Commission as alternative telecommunications utilities under Wis. Stat. § 196.50(2)(j)1.a., or telecommunications utilities under Wis. Stat. § 196.50(2)(j)1.b.

<u>3</u> Assessments apply to resellers with \$200,000 or more of annual assessable revenues, as set forth in Wis. Admin. Code ch. PSC 168. For resellers with less than \$200,000 annual revenue, those entities are currently subject to an annual fee. The current annual fee is \$100.
