
WHEREAS, to provide greater equity for the cost the Common Council desires to place the entire public fire protection charge on the utility bills as a direct charge for all General Customer users; and







WHEREAS, the Village desires to use the equivalent meter method of calculating the direct charge.






WHEREAS, the Village of Montfort seeks to partially shift the charges of Public Fire Protection from the general tax levy to direct charge of the utility; and

Whereas, the Lake Geneva Utility Commission is pursuing a 36% water rate increase with an estimated increase in the public fire protection charge at \$84,000.



**PUBLIC NOTICE TO ALL CUSTOMERS OF
CAMPBELLSPORT WATER UTILITY**

Effective April 8, 2011 the Village of Campbellsport will be paying a reduced amount of the water utility charge for public fire protection (PFP) service. In the past, the total charge was paid and, in turn, recovered its payment through property taxes. As such, Campbellsport Water Utility has requested Public Service Commission authorization to collect some of the PFP charges from each customer, or benefiting person, on the water utility bill based on the Equivalent Meter Method, in accordance with Wis. State. Sec. 196.03(3)(b), which reads as follows:

196.03(3)(b). Unless the governing body of the city, village or town adopts a resolution providing that the city, village or town will pay the retail charges for the production, storage, transmission, sale and delivery or furnishing of water for public fire protection purposes that are not included in general service charges:

1. A public utility shall include the charges in the water utility bill of each customer of the public utility in the city, village or town.
2. A municipal utility may, in addition to including the charges in water utility bills under subd. 1., bill the charges to any person who meets all of the following conditions:
 - a. The person is not a customer of the municipal utility
 - b. The person owns land that is located in the city, village or town and in an area in which the municipal utility has an obligation to provide water for public fire protection.

This change in billing for PFP will allow for the collection of a portion of PFP charges from property owners who are not subject to property taxes. The Village intends to charge non-general service customers as defined in subd. 2. above. The proposed quarterly PFP charges are as follows:


WHEREAS, the Village has included the public fire protection charge due the water utility on the Village's tax levy,

RESOLUTION AUTHORIZING THE DIRECT CHARGE OF PUBLIC FIRE PROTECTION

WHEREAS, the Village of Campbellsport, Fond du Lac County, Wisconsin (the "Municipality") owns and operates the Water Utility (the "Utility") as a public utility; and

WHEREAS, the Municipality provides public fire protection for the benefit of the public health, safety, and well-being of its residents; and

WHEREAS, the Utility is authorized by the Wisconsin Public Service Commission to recover the cost of providing and maintaining fire hydrants used for public fire protection; and

WHEREAS, the Municipality has determined it is in the public interest to change the manner in which public fire protection fire charges are paid for combination of a municipal charge (via tax roll) basis and direct charge on water bills, to a direct charge on water utility bills only based on an equivalent meter basis, thus, allowing for the collection of public fire protection charges from property owners not presently subject to property taxes; and

WHEREAS, \$10,000 of Public Fire Protection Charges shall be a direct charge on water utility bills and the remaining balance of Public Fire Protection Charges shall remain on the tax roll. The Wisconsin Public Service Commission cost of service study results tentatively indicate a total public fire protection charge of \$184,207.00 for 2011; and


WHEREAS, in accordance with Wis. Stat. Sec. 196.03(3)(b), the Municipality has chosen to have the Utility bill a specific dollar amount for public fire protection;

NOW, THEREFORE, BE IT RESOLVED, that the new basis for public fire protection shall be \$184,207.00, which includes \$10,000.00 which will be collected through direct charge on quarterly utility bills for public fire protection based on an equivalent meter basis and the remaining current balance of \$174,207.00 to continue being placed on the tax roll; and

BE IT ALSO RESOLVED, that this change shall be effective upon review and approval by the Public Service Commission of the State of Wisconsin

Effective Date. This Resolution shall take effect immediately upon its adoption and approval.
